# **Donor Spotlight**

As we noted in our last newsletter, in November, 2013, a \$50,000 gift to seed an endowment was made by longtime friends of the Infant Welfare Society of Evanston. Our benefactors have known of IWSE for many years through other charitable endeavors. Recently, we spoke with the donors to learn some of the reasons they chose to establish this endowment.

After carefully researching our mission and programs, they selected IWSE as a sound investment for meeting the goals of their foundation. Their mission focuses on educational programs as a means to advance the needs of children and youth. They believe that "we must invest in early childhood education to ensure a viable and productive future for all children. A sound start for even the youngest child offers an opportunity to thrive and grow beyond the limitations life may impose." As philanthropists, they recognize the importance of a solid financial footprint to guarantee future stability and growth of an organization. They understand annual public funding for early childhood education programs can be unpredictable, challenging this needed stability. Their hope in establishing an endowment for IWSE is to generate interest income through careful fiscal management of this gift. This will offer annual support for IWSE programs that will live well beyond the initial investment.

IWSE has always responded to the changing needs of families with young children in our community, and we look to our new century with anticipation. As the endowment grows, it will help ensure infants and toddlers in IWSE programs will continue to thrive. As our donors noted, they will to gain needed cognitive, social-emotional, physical and language skills that are the

foundation for future school and life success. We are deeply grateful our donors chose to make our work part of their legacy.

At our Centennial event last November, we challenged ourselves to match the seed gift by the end of our fiscal year in June 2014. Through the generosity of many in attendance, nearly \$27,000 was pledged that evening to support this ambitious goal.
